

SUMMARY ANNUAL REPORT FOR JACKSONVILLE UNIVERSITY WELFARE BENEFITS PLAN

This is a summary of the annual report of the Jacksonville University Welfare Benefits Plan, a health, life insurance, dental, vision, temporary disability and long-term disability plan (Employer Identification Number 59-0624412, Plan Number 505), for the plan year 01/01/2022 through 12/31/2022. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Jacksonville University has committed itself to pay certain Health and Healthcare Flexible Spending Account claims incurred under the terms of the plan.

Insurance Information

The plan has insurance contracts with Florida Combined Life, Humana Insurance Company, Standard Insurance Company, American Heritage Life Insurance Company, Professional Insurance Company and Colonial Life & Accident Insurance Company to pay certain Dental, PPO contract, Vision, Life insurance, Accidental Death and Dismemberment, Voluntary Life, Voluntary AD&D, Long-term disability, Temporary disability, Voluntary Worksite Cancer, Heart/Stroke, Voluntary Worksite claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2022 were \$702,870.

Because they are so called "experience-rated" contracts, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending 12/31/2022, the premiums paid under such "experience-rated" contracts were \$438,983 and the total of all benefit claims paid under these experience-rated contracts during the plan year was -\$130,300.

Paperwork Reduction Act Statement
