DOLPHIN SIGHTINGS

In May, Special Collections Coordinator, **John Harwick** represented JU at the Society of Florida Archivists' annual conference in Tallahassee at Florida State University. His presentation detailed Swisher Library's ongoing efforts in the digitization of university archives, planning and execution of exhibits for the 22-23 academic year, and increasing online collections' access. In addition to special access to rare historical documents within Florida State Archives and FSU's special collections, his networking led to requests from several archivists to tour JU special collections and to learn how to implement digitization of their collections.

The School of Aviation Program in the Davis College of Business & Technology is celebrating 40 years of training students to be professional pilots, air traffic controllers and aviation executives. The JU School of Aviation, accredited by the Aviation Accreditation Board International, was founded as the Division of Aeronautics in 1983 and has graduated nearly 860 total students since its doors first opened.

The National Security Agency and a committee of academic peers from the National Centers of Academic Excellence in Cyber Defense Programs has validated the Bachelor of Science in Cybersecurity, through the academic year 2028 within the Davis College of Business & Technology.

Congratulations to **Dr. Gretchen Bielmyer-Fraser**, Professor of Chemistry, and **Dr. Annmarie Kent-Willette**, Professor of Communication, for being awarded the *EPIC Grant Award*. The grant is designed to strengthen existing and develop new academic support systems and resources that will enhance both teaching and learning at JU. The research project focuses on graduate and undergraduate interdisciplinary research in Marine Science, Chemistry, and Communication. The students involved will discuss their research in a series of videos (produced by the communication students). As deliverables, a strategic social media campaign utilizing Instagram, TikTok, YouTube, and Facebook will be created for the Millar Wilson laboratory. This endeavor will also provide great publicity outside of the campus community, allowing JU to serve as a resource for educators, students, and potential recruits to the university. This project will expand the learning ecosystem of both JU affiliates and beyond. At JU the project will be incorporated to varying extents in several classes offered during the Fall of 2023 and Spring of 2024. These include lower and upper division undergraduate courses and graduate thesis credits in the departments of Biology and Marine Science, Chemistry, and Communication.
